#### 1.Introduction

Hounslow Children's Services and Hounslow Safeguarding Children Partnership (HSCP) are committed to ensuring that all paid staff and volunteers, who have contact with children and their parents are aware of their safeguarding responsibilities and have the required knowledge and skills to undertake these duties.

The provision of extensive and high quality single and multi-agency safeguarding training is therefore central to ensuring the safety and wellbeing of children and young people in the borough.

As such, from September 2023, there will be a full training needs analysis undertaken of the learning offer (including eLearning). As part of this process, some training courses will also be paused for review; in line with the Multi-agency Training Strategy September 2023 - 2025.

### 2. Agency Training Pathways

Our learning and development offer is continuously evolving with the aim of sharing both national and local, up to date, best practice via a range of learning events. These include self-directed digital learning, instructor lead courses and specific learning events, for both single and multi-agency.

## 3. Training for Hounslow Children's Services Staff

### 4. Multi-Agency Training

Most professional bodies have their own induction and learning requirements and statutory guidance. The learning offered within this brochure is in addition to individual professional requirements, building on shared priorities within the borough and opportunities for multiagency learning events to share good practice.

We do not provide specific Designated Safeguarding Lead (DSL) training for schools. We would encourage those who have completed DSL training, to undertake further training, in line with HSCP priorities.

All learning offered, assumes a pre-existing basic knowledge of safeguarding & child protection (training level 1). The table on the following pages is offered as guidance, if you are unsure as to whether you meet this basic level requirement, please refer to the full competency framework in the Training Strategy 2023 - 2025.

2 – Provided by individual agencies	<ul> <li>The requirements of Training level 1;</li> <li>Recording and sharing of information regarding concerns;</li> <li>Using the Framework for the Assessment of Children in Need and their Families;</li> <li>·Working together to identify, assess and meet the needs of children where there are safeguarding concerns. To identify child focused interventions and measurable outcomes;</li> <li>·Understanding the possible impact of parenting difficulties, such as domestic abuse, mental health, substance misuse, learning difficulties on parenting capacity;</li> <li>·Recognising the importance of family history and functioning;</li> <li>Working with children and family members, including addressing lack of co-operation and superficial compliance within the context of role.</li> </ul>
3 – Provided by individual agencies (role specific) or HSCP	<ul> <li>The requirements of Training level 2;</li> <li>Conducting section 47 enquiries, attending Child Protection Conferences and managing Core Groups; roles, responsibilities and collaborative practice;</li> <li>Using professional judgements to make decisions as to whether a child is suffering, or is likely to suffer, significant harm;</li> <li>Working with complexity;</li> <li>Taking emergency action;</li> <li>Communicating with children in line with interviewing vulnerable witness guidance;</li> <li>Promoting effective, professional practice;</li> <li>Supervising child protection cases and advising others.</li> </ul>

Managing performance to promote effective inter-agency practice;</li> <li>Specialist training to undertake key management and/or supervisory roles in, for example, intake/duty teams;</li> <li>Safer Recruitment Training.</li> </ul>
5. Provided by individual agencies (role specific) or HSCP	<ul> <li>The requirements of Training Level 4;</li> <li>Section 11 expectations, roles and responsibilities;</li> <li>Expectations on members in order to promote effective cooperation that improves effectiveness;</li> <li>Current policy, research and practice developments;</li> <li>Implementation of lessons from LCSPRs / Learning and Improvement Reviews and multi-agency audits. Specialist training to undertake specific roles, for example Independent Chair/Scrutineer; Service Manager;</li> <li>Safer Recruitment Training.</li> </ul>

Centre of expertise on child sexual abuse

The Centre of expertise on child sexual abuse provide multi-agency training on Familial Child Sexual Abuse. There are no dates currently planned – agencies will be alerted when any further training dates are agreed.

### 9. Training Expectations

So that all attendees to benefit from the instructor lead learning events on offer, it is essential at everyone feels comfortable and is able to fully contribute to the learning.

# DISTINGUISHING ACCIDENTAL AND NON-ACCIDENTAL INJURY

The session builds knowledge and confidence to recognise possible non accidental injuries and supports initial decision making about when it is necessary to seek specialist medical advice about injuries to children.

#### Benefits of attending

- Using images familiarise you with the accidental injuries that children and young people are likely to sustain
- Compare accidental and non-accidental injuries to understand how they might be differentiated
- Likely areas of nonaccidental injury – Think about which parts of the body are more likely to be injured non-accidentally
- Develop confidence in initial decision making about the need to take action
- Clarity about the action to take if concerned about a child

## PARENTAL SUBSTANCE MISUSE AWARENESS AND TREATMENT

Parental substance misuse is one of three major areas of known risk to children's health development and welfare. This course is provided to develop essential learning regarding Parental Substance Misuse.

#### Benefits of attending

- Enable practitioners to identify when there could be an issue with a parent or carer's substance misuse
- Know commonly used substances, their classes, methods of use and potential impact on parenting
- Examine personal and societal beliefs about drug and alcohol users, including stereotypes and myths
- Know and understand treatment models delivered at ARC
- Appreciate the Cycle of Change to enable behaviour change

## YOUTH MENTAL HEALTH FIRST AID — TWO DAY COURSE

This course aims to equip the non mental health specialists with the knowledge and skill to provide Mental Health First Aid to young people ensuring those who need it can access appropriate help quickly.

#### Benefits of attending

- Learn practical skills to spot the triggers and signs of mental health issues and enhanced interpersonal skills such as non-judgemental listening
- Knowledge to help a young person recover their health guiding them to further support -through self-help sites, place of learning, the NHS, or a mix - engaging with parents, carers and external agencies where appropriate
- Tools to look after your own mental well being

## MULTI-AGENCY PRACTICE & QUALITY OF CARE FOR CHILDREN LIVING WITH NEGLECT

Explore how individual practitioners can better collaborate and work together to improve work with families at all levels of concern from early help/prevention, child in need and child protection, with a focus on neglect.

#### Benefits of attending

- Gain a more sophisticated appreciation of the varied nature and presentation of neglectful parenting
- Have the chance to consider the use of our structured judgement Quality of Care tool to assist professional assessment
- Develop a deeper understanding of the challenges of working with neglect at a local level
- Space to think about direct work with children and young people to improve their lives
- A chance to further explore the impact of neglect on different areas of a child's care including how neglect enables other forms of harm

# SUBSTANCE MISUSE AND WORKING WITH YOUNG PEOPLE

This session is designed to provide professionals with understanding substance misuse and abuse, the risks involved and the capacity to engage young people in open and confidential conversations about substance use.

#### Benefits of attending

- Increase knowledge of drugs (including alcohol), the effects on one's health, the law and recognising indicators of substance use
- Discuss current trends and prevalence rates
- Develop an insight about young people's motivation for using drugs including alcohol
- Discover ways in which substance misuse is quantified and tested
- Explore associated risks such as mental health, sexual exploitation and gang involvement etc

# DOMESTIC ABUSE AND VIOLENCE AN INTRODUCTION

This course offers professionals the opportunity to explore, reflect and gain insight and understanding to be able to better connect with and help those who find themselves exposed to abuse and violence from their partner.

#### Benefits of attending

- Better understand the impact of being subject to relationship abuse
- Consider the dynamics of power and control
- Understand perpetrators diversionary reactions to professional's interventions
- Explore the role that alcohol and other drugs have in many abusive relationships.
- Appreciate the importance of early intervention

# CRIMINAL AND SEXUAL EXPLOITATION - SAFEGUARDING YOUNG PEOPLE

Develop professional awareness of how abuse is organised and perpetuated. Consider which systems are needed to co-ordinate better detection of offenders and improved protection of children and young people.

#### Benefits of attending

- Develop understanding of how sexual and criminal exploitation is organised to entrap young people
- Explore common attitudes underlying professional failures to protect young people and be able to recognise these in practice
- Familiarise you with the way in which you should respond procedurally to concerns and be aware of local initiatives to combat this form of child sexual abuse
- Understand the abuse of boys who are often forgotten and explore how young people are groomed and entrapped

## FAMILIAL CHILD SEXUAL ABUSE — TWO DAY COURSE

This course aims to equip professionals across the children's workforce with basic knowledge about familial sexual abuse and enhance confidence in our existing communication skills with children and young people.

#### Benefits of attending

- Develop an understanding of the findings from Hounslow's Audit
- Know the signs and indicators of sexual abuse
- Consider how to work with the power dynamics within the family
- Understand sexually harmful adults behaviour
- Consider the impact of sexually harmful adults behaviour on practice

## HARMFUL SEXUAL BEHAVIOUR & SIBLING SEXUAL ABUSE — TWO DAY COURSE

This course aims to equip professionals with increased awareness and understanding of the nature of harmful sexual behaviour in children and young people, improve assessment and intervention and enable better support to the families involved.

#### Benefits of attending

- Improved ability to identify whether sexual behaviour is developmentally appropriate, problematic, or harmful
- Greater understanding of prevalence and possible pathways to harmful sexual behaviour and sibling sexual abuse
- Develop capacity to create robust and effective safety plans to better manage harmful sexual behaviour and sibling sexual abuse
- Improved confidence in supporting non-abusing family members in their response to and management of harmful sexual behaviour
